The Power Breezer offers a dispersal mechanism to disinfect large areas against the Coronavirus by utilizing its atomizing technology to convert water soluble EPA or CDC recommended disinfectants to vapor and blowing the cleansing vapor up to 65 feet in a 60 degree cone.

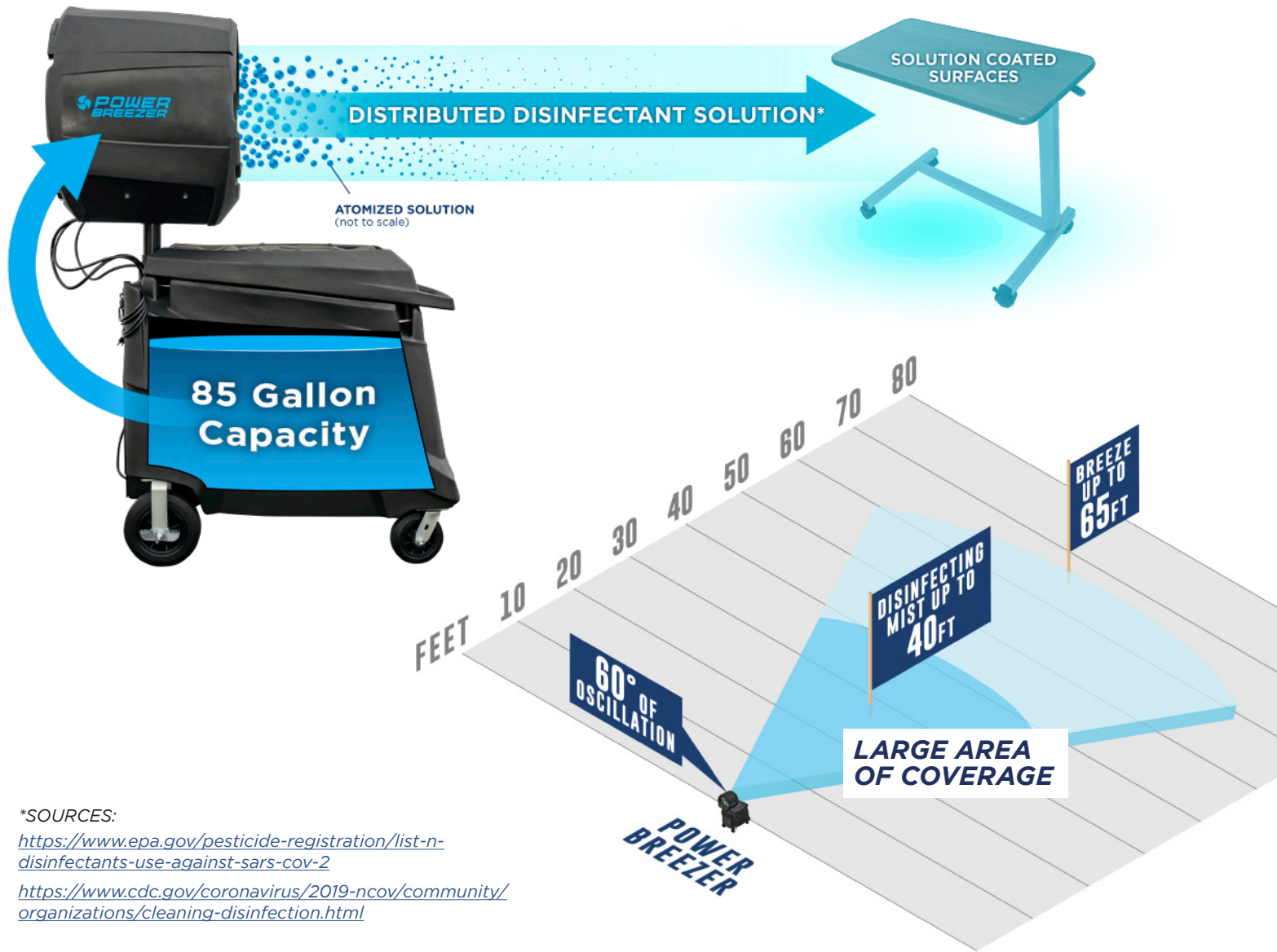


Putting a layer of cleansing vapor over open areas with tables, equipment, racks, conveyors and other surfaces that will be continually touched can help disinfect and mitigate the future spread of COVID-19. EPA/CDC has 3 requirements for the Power Breezer integrated solution to disinfect for Coronavirus.

1

Fill the Power Breezer tank with the **disinfectant/water mix per EPA/CDC guidelines**

2

It must **create a film on the surface area**

3

It must have a **dwelt time on the surface for 10min or EPA/CDC guidelines**

SAFEGUARDS:

- Do not mist directly on people and ventilate area after dispensing.
- Follow disinfectant manufacturer and EPA/CDC guidelines for usage, efficacy, safety, and all protocols.
- Be careful of slip hazards due to water solution layer on floors and equipment.
- To mitigate the corrosive effects on the Power Breezer, we recommend a weekly running only water through the unit.
- This is intended as a mitigation tool, and not as a one stop solution to COVID-19/Coronavirus.
